#### I. INTRODUCTION

Cu-Zn superoxide dismutase-1 (SOD-1) is a well characterized cytosolic scavenger of oxygen free radicals that requires copper and zinc binding to potentiate its enzymatic activity. Enzymatically, SOD-1 facilitates the dismutation of oxygen radicals to hydrogen peroxide and also catalyzes pro-oxidant reactions, which include the peroxidase activity and hydroxyl radical generating activity. SOD-1 is ubiquitously expressed in somatic cells and functions as a homodimer. Defects in the gene encoding SOD-1 have been implicated in the progression of neurological diseases, including amyotrophic lateral sclerosis (ALS), a neurodegenerative disease characterized by the loss of spinal motor neurons, Down syndrome and Alzheimer's disease. In familial ALS, several mutations in SOD-1 predominate, resulting in the loss of zinc binding, the loss of scavenging activity of SOD-1, and correlate with an increase in neurotoxicity and motor neuron death.

#### II. ASSAY PRINCIPLES

The Cohesion Bioscience Human SOD1 ELISA (Enzyme-Linked Immunosorbent Assay) kit is an in vitro enzyme-linked immunosorbent assay for the quantitative measurement of Human SOD1 in Cell Culture Supernatants, Serum, Plasma. This assay employs an antibody specific for Human SOD1 coated on a 96-well plate. Standards and samples are pipetted into the wells and SOD1 present in a sample is bound to the wells by the immobilized antibody. The wells are washed and biotinylated anti-Human SOD1 antibody is added. After washing away unbound biotinylated antibody, HRP-conjugated streptavidin is pipetted to the wells. The wells are again washed, a TMB substrate solution is added to the wells and color develops in proportion to the amount of SOD1 bound. The Stop Solution changes the color from blue to yellow, and the intensity of the color is measured at 450 nm.

#### IV. STORAGE AND STABILITY

All kit components are stable at 2 to 8 °C. Standard (recombinant protein) should be stored at -20 °C or -80 °C (recommended at -80 °C) after reconstitution. Opened Microplate Wells or reagents may be store for up to 1 month at 2 to 8 °C. Return unused wells to the pouch containing desiccant pack, reseal along entire edge. Note: the kit can be used within one year if the whole kit is stored at -20 °C. Avoid repeated freeze-thaw cycles.

## V. MATERIALS REQUIRED BUT NOT PROVIDED

- 1. Microplate reader capable of measuring absorbance at 450 nm.
- 2. Adjustable pipettes and pipette tips to deliver 2  $\mu$ l to 1 ml volumes.
- 3. Adjustable 1-25 ml pipettes for reagent preparation.
- 4. 100 ml and 1 liter graduated cylinders.
- 5. Absorbent paper.
- 6. Distilled or deionized water.
- 7. Computer and software for ELISA data analysis.
- 8. Tubes to prepare standard or sample dilutions.

#### VI. HEALTH AND SAFETY PRECAUTIONS

- 1. Reagents provided in this kit may be harmful if ingested, inhaled or absorbed through the skin. Please carefully review the MSDS for each reagent before conducting the experiment.
- 2. Stop Solution contains 2 N Sulfuric Acid ( $H_2SO_4$ ) and is an extremely corrosive agent. Please wear proper eye, hand and face protection when handling this material. When the experiment is finished, be sure to rinse the plate with copious amounts of running water to dilute the Stop Solution prior to disposing the plate.
- 3. Standard protein and Detection Antibody containing Sodium Azide as a preservative.

#### VII. REAGENT PREPARATION

#### 1. Sample Preparation

Store samples to be assayed within 24 hours at 2-8°C. For long-term storage, aliquot and freeze samples at -20°C. Avoid repeated freeze-thaw cycles.

**Cell culture supernates**: Remove particulates by centrifugation, assay immediately or aliquot and store samples at -20°C.

**Serum**: Allow the serum to clot in a serum separator tube (about 4 hours) at room temperature. Centrifuge at approximately 1000 X g for 15 minutes. Analyze the serum immediately or aliquot and store samples at -20°C.

**Plasma**: Collect plasma using heparin or EDTA as an anticoagulant. Centrifuge for 15 minutes at 1500 X g within 30 minutes of collection. Assay immediately or aliquot and store samples at -20°C.

**Cell Lysates:** Collect cells and rinse cells with PBS. Homogenize and lyse cells throughly in lysate solution. Centrifuge cell lysates at approximately 10000 X g for 5 minutes to remove debris. Aliquots of the cell lysates were removed and assayed.

**Bone Tissue:** Extract demineralized bone samples in 4 M Guanidine-HCl and protease inhibitors. Dissolve the final sample in 2 M Guanidine-HCl.

**Tissue Homogenates:** Rinse tissue with PBS to remove excess blood, chopped into 1-2 mm pieces, and homogenize with a tissue homogenizer in PBS or in lysate solution, lysate solution: tissue net weight = 10ml : 1g (i.e. Add 10ml lysate solution to 1g tissue). Centrifuge at approximately 5000 X g for 5 minutes. Assay immediately or aliquot and store homogenates at -20°C. Avoid repeated freeze-thaw cycles.

**Urine**: Urinary samples should be cleared by centrifugation and then can be used directly without dilution. Storage at -20°C.

#### 2. Human SOD1 Standard Preparation

Reconstitute the lyophilized Human SOD1 Standard by adding 0.5 ml of Standard/Sample Diluent to make the 5000 pg/ml standard stock solution. Allow solution to sit at room temperature for 5 minutes, then gently vortex to mix completely. Use within one hour of reconstituting. Two tubes of the standard (2.5 ng per tube) are included in each kit. Use one tube for each experiment.

Perform 2-fold serial dilutions of the top standards to make the standard curve within the range of this assay (78 pg/ml - 5000 pg/ml) as below. Standard/Sample Dilution Buffer serves as the zero standard (0 pg/ml).

**Note:** The standard solutions are best used within 2 hours. The 5000 pg/ml standard solution should be stored at 4°C for up to 12 hours, or at -20°C for up to 48 hours. Avoid repeated freeze-thaw cycles.

3. HRP-Labeled Detection Antibody Working Solution Preparation

The Biotin-Labeled Detection Antibody should be diluted in 1:100 with the Detection

Antibody Diluent and mixed thoroughly. The solution should be prepared no more than 2 hours prior to the experiment.

# 4. Wash Buffer Working Solution Preparation

Pour entire contents (30 ml) of the Wash Buffer Concentrate into a clean 1,000 ml graduated cylinder. Bring final volume to 600 ml with glass-distilled or deionized water (1:20).

VIII. ASSAY PROCEDURE

The TMB Substrate Solution must be kept warm at 37°C for 30 minutes before use.

When diluting samples and reagents, they must be mixed completely and evenly.

Standard detection curve should be prepared for each experiment. The user will

decide sample dilution fold by crude estimation of protein amount in samples.

1. Add 100  $\mu$ l of each standard and sample into appropriate wells.

2. Cover well and incubate for 90 minutes at room temperature or over night at 4°C

with gentle shaking.

3. Remove the cover, discard the solution and wash plate 3 times with Wash Buffer

Working Solution, and each time let Wash Buffer Working Solution stay in the wells

for 1 - 2 minutes. Blot the plate onto paper towels or other absorbent material. Do

NOT let the wells completely dry at any time.

4. Add 100  $\mu$ l of HRP-Labeled Detection Antibody Working Solution into each well

and incubate the plate at 37°C for 60 minutes.

5. Wash plate 3 times with Wash Buffer Working Solution, and each time let Wash

Buffer Working Solution stay in the wells for 1 - 2 minutes. Discard the Wash Buffer

Working Solution and blot the plate onto paper towels or other absorbent material.

6. Add 100 µl of TMB Substrate Solution into each well and incubate plate at 37°C in

dark for 30 minutes.

7. Add 100 µl of Stop Solution into each well. The color changes into yellow

immediately.

8. Read the O.D. absorbance at 450nm in a microplate reader within 30 minutes after

adding the Stop Solution.

For calculation, (the relative O.D.450) = (the O.D.450 of each well) - (the O.D.450 of Zero well). The standard curve can be plotted as the relative O.D.450 of each standard solution (Y) vs. the respective concentration of the standard solution (X). The concentration of the samples can be interpolated from the standard curve.

**Note:** If the samples measured were diluted, multiply the dilution factor to the concentrations from interpolation to obtain the concentration before dilution.

#### IX. ASSAY PROCEDURE SUMMARY

- Prepare all reagents, samples and standards
- Add 100 ul Standard or Sample
- Wash plate 3 times with Wash Buffer Working Solution
- Add 100 ul HRP-Labeled Detection Antibody Working Solution
- Wash plate 5 times with Wash Buffer Working Solution
- Add 100 ul TMB Substrate Solution
- Add 100 ul Stop Solution
- Read the plate at 450nm



#### XI. SENSITIVITY

The minimum detectable dose of Human SOD1 is typically less than 40 pg/ml.

#### XII. SPECIFICITY

The Human SOD1 ELISA Kit allows for the detection and quantification of endogenous levels of natural and/or recombinant Human SOD1 proteins within the range of 78 pg/ml - 5000 pg/ml.
